Thank you for your letter of 8 August addressed to the Justice Secretary on behalf of your constituent, Mark Russell of 25 Westby Road, Lytham St Annes, Lancashire FY8 2EJ regarding his court case. I am responding as the Minister with responsibility for courts.

I am sorry to learn of the difficulties that Mr Russell has faced and the impact that pursuing his case through the court has had on his life. I appreciate that Mr Russell is concerned with the outcome of the hearing before Her Honour Justice Beach and feels that the evidence was not considered properly.

How a case is managed, including the evaluation of evidence and the final decision, is a matter for the judge and as a Government Minister I cannot comment or intervene. This is not through any lack of concern for Mr Russell, but because judges are independent of government and must be free to make their decisions without interference.

I understand that Mr Russell would like to speak to the Health Secretary regarding a number of points, and you may wish to write to the Department of Health on Mr Russell's behalf for these to be considered.

Thank you for your letter of 8 August to the Rt Hon Jeremy Hunt MP, Secretary of State for Health, on behalf of your constituent Mr Mark Russell of 25 Westby Road, Lytham St Annes FY8 2ES about the Health and Care Professions Council (HCPC). I am replying as the issues you raise fall within my ministerial portfolio.

I was sorry to read of Mr Russell's continuing concerns about the HCPC.

As set out in previous correspondence, however, the Secretary of State cannot comment on individual circumstances.

The HCPC is an independent regulator charged with the responsibility of taking appropriate action against individuals where necessary. Whilst I appreciate Mr Russell's disappointment at the verdict, the Government's position remains as set out in previous letters. The decision to initiate criminal proceedings is a matter for the HCPC and then for the court to adjudicate, with the benefit of legal argument and evidence before it in each case.

I am sorry I cannot be more helpful.

Thank you for your letter of 8 August concerning your constituent Mark Russell.

Given that Mr Russell's case has gone before a court which has passed down a decision, I'm afraid I don't think that it would be appropriate for me to look any further into his case or to pursue it on his behalf. I can appreciate his dissatisfaction, even distress, at the situation in which he finds himself, but I'm afraid I really cannot intervene at this stage.

The Committee holds periodic accountability hearings with the health and social care regulators, including the Health and Social Care Professions Council. The Committee has no current plans for a hearing with the HCPC, but the broader questions raised by Mr Russell's case concerning the use of protected titles is one which I would expect the Committee to raise with the Council if and when it does hold such a hearing.

I am sorry not to be able to be of any further assistance.
